\_\_\_\_\_, a current or prospective member of the Institute of Contemporary Psychoanalysis ("ICP"), acknowledges the following requirements for continued membership in the ICP:

- To be a Training & Supervising Analyst, participation in a minimum of 10 (ten) full-length (ninety-minute) member study group sessions per year is required for five years.
- All members' (including candidates and analysts, new members from outside the ICP, and continuing members) dues and past tuition must be current and fully paid before the ICP will admit the graduated candidate as a member, or renew an existing membership (with the exception of any dues which will convert under a previously signed promissory agreement

with the ICP).

- All membership dues are payable by January 15<sup>th</sup>. If a membership is applied for with fewer than 12 months left in the membership year, the membership fee will be prorated.
- All members paying their dues on a monthly basis will be required to provide a credit card on file or ensure direct payment from their bank.
